2018 STANDING RULES RATIONALE FOR CHANGES AND QUESTIONS

Changes for this year are in red. Areas in question are highlighted in yellow. Page 1:

- Under "OFFICERS", first paragraph, second line "Assistant Registrar" has been deleted. It was not an elected office last year, and it is thought that the Registrar may seek assistance as needed or an assistant may appoint an assistant.
- Under "OFFICERS", last sentence Since we don't presently have a Young Adult School (and have not had one in several years, it was decided to put this at the end of the paragraph, preceded with the words, "If appropriate".
- Under "OFFICERS", second paragraph, at the end of the first sentence the words "at the Four-Day School, Weekend Event and Day Sampler" has been changed to "at all events". The rationale is that whether or not a Four-Day School will be held.
- Under "OFFICERS", third paragraph, first sentence the words "if appropriate" is placed before "The Young Adult School Coordinator and Assistant". Rationale is the same as above second bullet.
- Under "OFFICERS", third paragraph, at the end This section has been added due to the fact that these positions often require specific skills and it is most useful to continue with their services.
- Under "OFFICERS", fourth paragraph this has been added ot agree with letter "e" of the Program Committee section.)
- Under "OFFICERS, fifth paragraph, last sentence this has been added to allow the return of persons with much to offer.

Page 2:

- Under "GENERAL RESPONSIBILITIES…", number 2 the words in red have been inserted for clarification.
- Under "GENERAL RESPONSIBILITIES...", number 4 the words in red have been added to the end of the sentence for emphasis.
- Under Audit Committee, a question while the members this committee are not specifically listed in this item, in other areas the Treasurer/Business Manager is listed as part of this committee. This is a conflict of interest and the Treasurer should never be part of an Audit Committee. To assure this doesn't happen, should that note be made in this section?
- Under "PROGRAM COMMITTEE", letter a in order to agree with other parts of this document, the words in red have been added.

Page 3:

- Under "PROGRAM COMMITTEE", old letter f because of recommendations and limits in other areas, this should be eliminated. (Originally read: "All appointed positions listed in B are considered to be one-year appointments".) Consecutive letters will be changed accordingly.
- Under "PROGRAM COMMITTEE". Old letter g this has been handled above and should be eliminated. (Originally read: "No one may serve more than four consecutive years in one position".) Consecutive letters will be changed accordingly.

Page 4:

- Under "YOUNG ADULT SCHOOL COMMITTEE" The words, "if appropriate" have been added to the beginning of this paragraph for reasons already listed.
- Under "KOREAN LANGUAGE EVENT COMMITTEE" The words, "if appropriate" have been added to the beginning of this paragraph for the same reasons as listed for the Young Adult School.
- Under "STAFFING, NURSE/EMT" after the words, "This shall be a yearly appointment" the words in red have been added to agree with items above.

Page 5:

- Under "FINANCIAL MATTERS", number 3 after "as established by the Finance Committee" the words in red have been added. This is done in practice, and should be in policy as well.
- Under "FINANCIAL MATTERS", number 3 at the end the words in red have been added due to discussion at the last meeting.

• Under "FINANCIAL MATTERS", number 6, the words in red have replaced the old name for the school. (also continued to page 6.)

Page 6:

- Under "AUTHORIZED SALES", first sentence the words "and ordered from the Mission Resource Center" has been deleted.
- Under "AUTHORIZED SALES", third line the words in red have been added.
